### EDUCATION IN TRAFFIC STATISTICS

#### LEGAL BASIS

The statistical activity is conducted in accordance with the Statistical Programme of Republika Srpska for the period 2026-2029 and pursuant to the Law on Statistics of Republika Srpska ("Official Gazette of Republika Srpska", No 85/03).

#### METHODOLOGICAL BASIS

##### Aim and content

The aim of education in traffic statistics is to produce data on the number of pupils and candidates who passed the driving test and data on lecturers and driving instructors.

##### Reporting units/ Observation units

Reporting units are all driving schools that submit data on education in traffic to the Institute for Adult Education of Republika Srpska.

Statistical observation units are all pupils who attend education in traffic, as well as lecturers and driving instructors.

##### Coverage

The coverage is full. The survey covers all pupils who attend education in traffic in Republika Srpska, as well as licensed lecturers and driving instructors.

##### Method and period of data collection

The data in this statistical activity are collected through the Annual report on driving tests taken. The data are collected once a year for the entire year, as on 31 December. This report is completed by the Institute for Adult Education, which obtains data from driving schools. Reporting units must submit data for the previous year by 21 February of the current year.

##### Protection of confidential data

Only aggregate data for the level of Republika Srpska are published. Confidential data are protected pursuant to Articles 25 and 27 of the Law on Statistics of Republika Srpska ("Official Gazette of Republika Srpska, No 85/03) and in accordance with the Rules of protection of confidential data.

## **Definitions**

Education in traffic is an activity carried out in accordance with a special programme. Training of candidates for drivers of motor vehicles covers the theoretical part (traffic safety regulations) and the practical part (motor vehicle steering and first aid programme). This activity is regulated by the Law on Road Traffic Safety in BiH ("Official Gazette of Bosnia and Herzegovina", No. 9/18), Regulations on training of drivers of motor vehicles ("Official Gazette of Republika Srpska", No. 74/18), Regulations on acquisition of vocation of driving instructor for motor vehicles (Official Gazette of Republika Srpska, No. 25/07), and Regulations on conditions and methods of obtaining the licence (Official Gazette of Bosnia and Herzegovina, No. 13/13).

## **IMPLEMENTATION ORGANISATION**

### **Authorities implementing the statistical survey**

The Republika Srpska Institute of Statistics is the responsible authority for the production of data on education in traffic. The Department for Society Statistics carries out the collection, entry and processing of data.

### **Obligation to provide data**

Reporting units must submit data to the Republika Srpska Institute of Statistics in accordance with the Law on Statistics of Republika Srpska.

## **IMPLEMENTATION FREQUENCY**

Reporting units must submit data to the Republika Srpska Institute of Statistics by 20 February. The data are published on 15 March.

## **PUBLISHING**

The data are published in the annual release "Education in Traffic", available at the website of the Republika Srpska Institute of Statistics.
